### 1. INTRODUCTION

This classification report defines the classification assigned to **Avery Dennison® MPI 2800 High Opacity series** in accordance with the procedures given in EN 13501-1:2007+A1:2009.

### 2. DETAILS OF CLASSIFIED PRODUCT

#### 2.1 GENERAL

The product, **Avery Dennison® MPI 2800 High Opacity series**, is defined as a multi-purpose vinyl.

#### 2.2 MANUFACTURER

#### 2.3 PRODUCT DESCRIPTION

According to the sponsor the product is composed of:

- Face film: 80 µm, gloss white polymeric calendered vinyl with high opacity properties;
- Adhesive: 20 µm, permanent, clear acrylic based;
- Backing paper: Clay coated kraft paper, 125 g/m<sup>2</sup>.

The product has a total thickness of approx. 100  $\mu$ m and a mass per unit area of approx. 130 g/m<sup>2</sup> (measured on the product).
